### **Dock Diving Rules**

Competitors will be judged by how far their dog jumps off the dock. Distance jumping is determined visually by the judge, at the point where the base of the dog's tail enters the water. An extra handler may be on the dock to release your dog, we will have volunteers to assist if desired. Each dog gets two jumps (back to back). The longest of the two will be the qualifying score. The top five dogs will have a "jump off" to determine the winner. Prizes will be awarded to the winning dogs, along with bragging rights! This is a FUN event and a fundraiser for the AAHS.

### **Registration**

Pre-Registration received online by 5:00 pm on August 28 is \$20.00 per dog. Day of registration is \$30.00 per dog. There will be no refunds for this fundraiser.

### **Dog Rules**

All breeds and mixes are invited and encouraged to participate! No experience necessary. Dogs must be on a leash no longer than six feet until it is their turn to jump. Dogs must be under control at all times. Pet clean up bags and trash cans will be provided. All dogs entered must have proof of current rabies vaccinations. Please have your dog wear current I.D. and rabies tags or bring a copy of your current rabies certificate on event day. DO NOT bring your dog if she is in heat. It is recommended dogs less than six months old not participate. Do not bring your dog if its behavior is dangerous. We reserve the right to refuse entry to aggressive animals.

### **Check-In**

Registration and/or check-in begins at 1:00 PM. Dock diving begins at 2:00 PM.

## Waiver and Release

I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OR LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me or my dog, or loss or damage to property owned by me, as a result of participation in this event. The AAHS and Richmond Lake Anchors Away are not responsible for any actions that may result from my participation in the event. The AAHS and Richmond Lake Anchors Away do not assume any responsibility for lost or stolen animals at the event. That in bringing my pet to participate in this event I understand that I am doing so at my sole risk. Any cost and expense and any harm that may come to the animal(s) shall be my sole responsibility; and in attending the competition with my pet(s), should any injury occur to any person, other animal, or property as a result of the behavior of my animals(s), whether expected or unexpected, regardless of the stimulus for the behavior (pets spontaneous conduct, conduct of another animal, conduct of any person or thing, or combination therein) I will be solely liable and held responsible for any injury, or property damage that results from my participation (including any attorney fees) and that will not indemnify, and hold harmless, protect and defend AAHS, Richmond Lake Anchors Away and its sponsors for any and all claims of damages and liability from injury, property damage, loss, claim or expense resulting from the behavior of my animal; and to report any and all such injuries or incidents to the AAHS and Richmond Lake Anchors Away and/or the additional named insureds.

I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, The AAHS and Richmond Lake Anchors Away (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in physical activity, or while on or upon the premises where the event is being conducted.

I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be constructed in accordance with the laws of the State of South Dakota.
